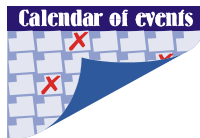

Law School News!

Documentary on WFYI Public Television. On January 21, 2010, 7:30 p.m., WFYI Public Television broadcast the documentary *Tough Decisions: Defending the Homeland*, a counter-terrorism simulation conducted at our law school on Friday, October 23, 2009. The Documentary takes viewers behind-the-scenes during a groundbreaking simulation of terrorism in Indiana's capital city. Produced by WFYI in partnership with the Indiana University School of Law-Indianapolis and the Indiana University School of Public and Environmental Affairs, *Tough Decisions* chronicled the minute-by-minute response as Law and SPEA students role-played government and civilian officials attempting to deal with an unfolding terrorist attack. Together, they determined the best course of action and communication. The action played out in several areas of the law school and was recorded and broadcast via a simulation "dashboard" that was live on the law school's website. Students in *Professor Shawn Boyne's Seminar in Comparative National Security Law* participated in bringing these events to life. **Note: This program will be rebroadcast on Channel 20.1 on Wednesday, March 24, 10:30 p.m., and again on Sunday, March 28, 12:30 a.m.**

Law School Hosts Regional Round of 35th Annual National Trial Competition. The Indiana University School of Law-Indianapolis was the official host of the Region 8 round of the 35th Annual National Trial Competition on February 18-20. Region 8 included teams from Chicago-Kent, DePaul, Indiana University-Indianapolis, Loyola, Northern Illinois, Northwestern, Southern Illinois, John Marshall, University of Illinois, Notre Dame and Valparaiso. Appellate Clinic Students, Beth Barnes and **Shannon White**, recently won reversals for their clients in two Appellate Clinic cases. *Beth Barnes'* client was convicted of possession of a firearm in an airport. The Court of Appeals reversed the conviction, reasoning that "mere forgetfulness does not satisfy the knowledge or intent requirement set out by the statute." *Shannon White's* client was convicted of invasion of privacy for violating a protective order. The Court of Appeals concluded "the State did not prove the client was subject to an active order of protection" when he was never provided written notice of the order or oral notice from an agent of the State. Both students were commended with high praise for their work by attorneys whom they had worked with from the Marion County Public Defender Agency. The Appellate Clinic was created and is overseen by *Professor Joel Schumm*, '98. Congratulations!

Client Counseling Competition Winners of this year's Intraschool Client Counseling Competition was the team of **Jonathan Faust** and **Matthew Keys**. The team of **Aaron Bentley** and **Jenai Mehra** were semi-finalists. *Jonathan* and *Matthew* traveled to Marquette School of Law in Milwaukee in February to represent the law school at the ABA CCC Regional in which they were semi-finalists in the regional round. Professor George Edwards delivered a lecture in the *Cutting Edge Lecture Series* held on the IUPUI campus on February 24th. In this series, top university professors engage the community in discussions about rapidly changing fields of inquiry. Professor Edwards lectured on *The 17th Century Trans-Atlantic Slave Trade to Hurricane Katrina--International Trade, Human Trafficking & The Right to Health*. He examined the applicability of international law to human rights issues in the U.S., Haiti, and other countries in the region affected by the Trans-Atlantic slave trade, and focused on vestiges of slavery, including health disparities between descendants of slaves and non-descendants. Professor Edwards also explored the relationship between international trading regimes under the World Trade Organization (WTO), and legal mechanisms in place to combat trafficking in humans.

EMERGENCY PREPAREDNESS INFORMATION

Indiana University has created a web page to provide resources for you about emergency preparedness; information will be updated as needed. From the IU homepage, <http://www.indiana.edu/>, go to: About IUPUI, Site Index, Emergency Preparedness. In the event of a building emergency for:

FIRE: Alarms will sound and evacuation is mandatory. Use closest stairway for exits. **DO NOT USE ELEVATORS.** Once outside, move to a safe place, if possible, to the parking lot west of the law school. Remain outside until the "all clear" is given.

TORNADO WATCH: The "campus siren" will sound - evacuation is NOT required.

TORNADO WARNING: Three blasts of an air horn in the Atrium will indicate **evacuation is necessary.** Evacuate **immediately** to the parking garage and use only the NW and SOUTH stairwells which have direct garage access. Remain in the garage until an "al clear" is given.

Bike Theft Prevention Tips

Bike thefts are on the rise not only on campus and the Indianapolis area in general, but nation wide. The increasing popularity as a sport and means of transportation has made bicycles an easy target for thieves. Theft prevention tips include:

1. Lock your bike to a bike rack and avoid locking items that can be easily cut, broken, or removed.
2. Use a steel U-shaped lock or even two locks. Lightweight cable or chain locks no longer provide adequate security in most areas.
3. Leave as little space as possible within the U lock to make it harder to pry open.
4. Keep lock off ground to avoid leverage to hammer or smash.
5. Position keyhole of lock to face ground to inhibit ability to manipulate the lock.
6. Remove front wheel and lock both wheel and frame together with U lock.
7. Take your bike seat with you if easily removed and/or expensive.
8. Record make, model, serial number and take a digital photo to assist police if stolen.
