FOR THE USE OF IUPUI'S WEB-BASED WORLD LANGUAGE PLACEMENT  
TESTS (INCLUDING FRENCH, GERMAN, AND SPANISH)  
FOR COURSE PLACEMENT PURPOSES  
AT IVY TECH COMMUNITY COLLEGE

The purpose of this agreement is to provide a general framework for Indiana University - Purdue University Indianapolis (IUPUI) on behalf of The Trustees of Indiana University, a state body politic, to offer Ivy Tech Community College (also hereby referred to as ITCC) the opportunity to use IUPUI's Web-based Language Placement Tests (in French, German, and Spanish) for course placement purposes at each of the statewide campuses of Ivy Tech Community College.

Faculty representatives at both institutions hereby agree to allow authorized staff members to access and administer IUPUI's Web-based Language Placement Tests to students enrolled at the statewide campuses of ITCC. Test coordinators will access the language placement tests at the following Web site: [http://tc.iupui.edu/test\\_apps/flpt/](http://tc.iupui.edu/test_apps/flpt/). This agreement is effective for a twelve (12) month period as of January 2, 2007, and will be automatically renewed for a successive twelve (12) month period; either party may terminate this agreement at any time upon providing the other party thirty (30) days' prior written notice.

With this agreement, Ivy Tech Community College will permit IUPUI to use ITCC's Test Centers (whenever computer labs are available) to administer **world language** placement tests to IUPUI students served through IUPUI's outreach testing services. It is agreed that neither institution will receive any monetary compensation for the provision of services offered through this agreement.

This agreement, including any modifications, may be reviewed by either institution upon request. Both institutions agree to keep the other aware of changes in placement testing policy and procedures as they occur. While both parties to the agreement understand that the purpose of this agreement is to facilitate course placement services at Ivy Tech Community College, they also recognize that limits may be placed on the appropriate uses of the students' placement test results. IUPUI expressly disclaims any and all warranties relative to its placement tests, placement test materials, and/or the information obtained from the tests, including without limitation to any warranty of conformity or fitness for a particular purpose or regarding the appropriateness, meaningfulness or usefulness (i.e., validity) of the placement test scores for course placement purposes at ITCC statewide campuses.
