FACULTY SENATE MEETING
PURDUE SCHOOL OF ENGINEERING AND TECHNOLOGY, IUPUI

Approved May 8, 2001

Senate President, Sanjiv Gokhale, called the meeting to order at 11:08 a.m.

The agenda was adopted and the minutes of the March 6, 2001 senate meeting were approved with the following clarification. The IUPUI Psychology Department with autonomy from Purdue awards one particular Ph.D. in Clinical Rehabilitation, this degree counts toward IUPUI's Research One status; all other Science and Engineering Ph.D. degrees are part of the West Lafayette's count.

Dean Yurtseven presented the Administration Report, *Attachment I*. A copy of the budget planning presentation is included (see Attachments). Comments were made regarding retention and satisfaction with advising as noted on the retention and graduation rates slide. Each year, the Office of Information Management and Institutional Research releases the results of the Continuing Student Satisfaction and Priorities Survey. One of the questions on the survey deals with student satisfaction with advising; survey results are sent to department chairs. One issue the school needs to decide is whether Learning Community Courses should be required, and if so, should these courses count toward graduation credit. The Educational Policy Committee has discussed this issue but no decision has been made. Dean Yurtseven hopes to receive an answer in mid-May regarding space allocation in the ET Basement. The CNT, EET, MET, and OLS faculty offices will be refurbished this summer. Please forward pertinent information regarding faculty activities, publications, awards, etc., to Dean Yurtseven so they may be included in the Dean's Report and other university publications.

IUPUI Faculty Council

Charlie Yokomoto gave an oral report on the April 5, 2001 Faculty Council Meeting. As a follow up, Marvin Needler submitted the following written report.

Chancellor Bepko presented a draft of “A Vision for Diversity at IUPUI” document. This document will be discussed at the May 3, 2001, Faculty Council meeting. Judith Palmer, IU Vice-President and Chief Financial Officer presented for information and discussion the “Plan for Financing 18-20” and the “Arthur Anderson Report on the Review of Non-Academic Administrative Services”, (<http://www.indiana.edu/resources/admreview/index.html>). Mark Brenner, IUPUI Vice-Chancellor for Research and Graduate Studies, presented for information and discussion the request for Faculty Council Endorsement of “Education Requirement on Research on Human Subjects”. Information on Human Subject Research may be found at the <http://www.research.indiana.edu/humans.html> website. The vote on endorsement will take place at the May 3, 2001 meeting. IUPUI Faculty Council President, Paul Galanti, reported that the University Faculty voted to approve two levels of lecturer appointments (Senior Lecturer and Lecturer). Paul also reported that post-tenure review is tied to a campus, not a discipline. Vania Goodwin, Nominating Committee Chair, presented the slate of nominees for election to the Executive and Nominating Committees. The election will be held at the May meeting. Bill Conrad will continue to serve on the Nominating Committee until June 2002. Vania announced the election results for the IUPUI Faculty Council At-Large Representatives. Charlie Yokomoto will be completing the second year of his term. Paul Galanti announced the election results for the University Faculty Council Representatives. Ken Rennels, Academic Affairs Chair, presented for council approval “Policy on Accommodation of Religious Observances”, see the <http://www.indiana.edu/~deanfac/relobs.html> website for details. The Indiana University Office of Academic Affairs & Dean of Faculties website <http://www.indiana.edu/~deanfac/holidays.html> lists major religious holidays. Ken Rennels presented for information the “Defining the Undergraduate Unit of Academic Credit”. This document was to be voted on at the May 3 meeting but was withdrawn. Kathy Johnson, Student Affairs Committee Chair, presented for information and discussion a “Recommendation to Ban the Sale of Cigarettes on Campus”. The council will vote on this recommendation at the May meeting. Miriam Langsam, Faculty Handbook Chair, updated the council on the status of next version of the Faculty Handbook. The IU Board of Trustees met on April 5, 2001 and discussed the housing issue at IUPUI, and establishment of a Post-Tenure Review Policy for campuses that do not have a policy. Many Faculty Council members joined the Trustees for dinner after the council meeting.

Other Business and Announcements

Harriet Wilkins reminded the senate that according to the Constitution the senate shall reapportion itself annually (Constitution, Section V., C). The ratio of senators to faculty members needs to be set; the pattern has been one senator for every four-faculty members per department. Andy Schaffer made the motion to adopt the one to four senator to faculty ratio; the senate voted to approve.

Sanjiv Gokhale reported that he had received a response from Chancellor Bepko regarding the February 13, 2001 senate resolution dealing with public advertising for IUPUI (van) reference document FS00-5-2. *Attachment II* (FS00-5-2 response) is a copy of Chancellor Bepko's response.

Dear Sanjiv:

We are very interested in the concerns of the faculty in the Purdue School of Engineering and Technology. In this very complex university environment, with its many identities, we must take special care to ensure that faculty members are comfortable with their roles and with the relationships they have with other parts of the campus and our universities. Your point about the ability to recruit students to the Purdue School of Engineering and Technology is of special concern to us. Also important is the point you have made about gaining support from local industry.

We have studied these issues of multiple identities at some length. Even after many years, a disappointing level of misunderstanding still exists in the community. Nevertheless, we believe that the answer is not to restructure our campus in some way to eliminate the complexity. Instead, it is to provide more and better information to people so that they can understand who we are and what we offer. We are a core campus of Indiana University -a unique combination of Indiana University and Purdue University that allows students to earn degrees from either one of those institutions here in the state's capital, at the very crossroads of Indiana. This is one of the points of the "Why Not Both?" campaign that has contributed to our maintaining, and even increasing, the size of our student body, while we have simultaneously referred more than 750 applicants this year to the Community College of Indiana.

The fact that we award both IV and Purdue degrees is only part of the story. It is also true that we sit equidistant from IV Bloomington and Purdue West Lafayette. This makes us a natural place of concourse between those two university centers and gives us a special role in encouraging the orchestration of advanced university resources among the three campuses to create Indiana's research corridor. Increasing numbers of multi campus activities, particularly between Bloomington and Indianapolis, give us hope that this corridor will be of extraordinary importance to the future of our state. Business and government leaders are talking more and more about this corridor and its potential to contribute to the state's emergence in new economies.

It is not inconsistent for IUPUI to be this place of concourse, to award only IU or Purdue degrees, and to still be a campus of Indiana University. This designation certainly does not impede the enormous flow of communications that highlight the fact that we have two Purdue schools at IUPUI.

I received your letter last Thursday afternoon and read it just prior to going to the Maynard Hine alumni leadership awards dinner that evening. At that dinner, one honoree, Gene Hunt, was an electrical engineering technology graduate of the Purdue University School of Engineering and Technology. The other honoree was Margret Robb, an IU law alum with a Purdue degree earned at West Lafayette.

Gene Hunt has been active in the Alumni Association of the Purdue School of Engineering and Technology at IUPUI, the IUPUI Alumni Relations Council, and the Purdue University alumni board based in West Lafayette. Because of Gene's prominence, Tom Carroll, the president of the Purdue Alumni Association worldwide was present, along with Larry Preo, the executive director of the Purdue Alumni Association. The only trustee of either university who stayed throughout the entire evening was John Hardin, an alumni-elected trustee of Purdue University. John Hardin also serves as the chair-elect of the IUPUI Board of Advisors. He will become chair in the 2002-2003 academic year and will serve for at least two years, in keeping with the pattern for Advisory Board chairs. Finally, the entertainment for the evening was the Purdue Glee Club.

They led the entire gathering in singing the songs identified with every part of our complex educational enterprise -the Purdue hymn, the IU alma mater, and the new IUPUI fight song. Also, several members of the IU Board of Trustees and President Myles Brand attended the reception for the Maynard Hine Alumni Leadership Awards Dinner, but had to leave to attend a special meeting of the board. Among those IU trustees was Dean Hertzler, a student studying in the Purdue School of Science at IUPUI, who will earn a Purdue degree in biology before he attends the IU School of Medicine.

Purdue President Martin Jischke will attend an IUPUI Faculty Council meeting, an Academic Deans Council meeting, and a meeting of our IUPUI Board of Advisors this spring. These visits, along with events such as the Maynard Hine dinner, highlight our profound Purdue connections.

It is inevitable that in this complicated environment references will be made to IU or Purdue that could be of concern to faculty members whose work is related to the other university. I think the right answer is to rise above those concerns. We are a partnership

campus. There are IU degree programs and Purdue degree programs. This is, however, a campus of Indiana University, which in partnership with Purdue, has the authority to offer Purdue programs. Long ago, we concluded that the confusion is an acceptable cost given the advantages that being a partnership campus has brought to the state.

While we will discuss the matter that you have raised within Indiana University, I do not want to mislead you about the likely conclusion. The Board of Trustees of Indiana University has not mandated signs on vans that state that IUPUI is a "campus of Indiana University." On the other hand, I doubt that anyone would be agreeable to removing accurate references already in place, such as the ones on the vans to which you object. We are, in fact, a campus of Indiana University, but one that has special features, qualities, and opportunities. Those features, qualities, and opportunities constitute us as one of the most promising and nationally significant urban campuses in the United States.

We do wish to address the issue of recruitment of students. This is of special importance to us, although we note that the enrollments in the Purdue School of Engineering and Technology have been among the fastest growing enrollments at IUPUI. Nevertheless, we will make a special review of marketing for the Purdue School of Engineering and Technology, and I will ask Cheryl Sullivan, Vice Chancellor for External Affairs, to lead this effort.

Meanwhile, I hope the faculty will reconsider its conclusions. To that end, Executive Vice Chancellor Bill Plater and I would be happy to meet with your faculty and to help explain these matters in more detail.
