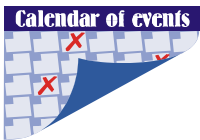

## Parking on Campus

**Park early! Park correctly! They do ticket!**

Valid permits are required to park on campus. Parking permits may be purchased online through Parking Services at [www.parking.iupui.edu](http://www.parking.iupui.edu). All vehicles parked in a permit lot must properly display a parking permit so that the letter designation and expiration date are clearly visible from the front of the vehicle. Parking regulations are enforced 24 hours a day, 7 days a week.

There are three parking garages convenient to the law school for "E" permit student parking: One on the corner of Michigan and Blackford Streets, one across from the Track & Field stadium at New York and Barnhill Drive, and also the Sports Complex garage off New York on Blake Street. **Free** off-campus parking is available at the north campus parking lot at 1200 Indiana Avenue in which a permit is also required. Students board a Jags Express shuttle from this lot and are brought to campus. Shuttles run 5:45 a.m.-10:00 p.m. when school is in session. ## Law School News!

### **IU Law-Indianapolis has Two Top 10 Programs!**

*U.S. News and World Report* ranked two programs at our law school in the Top 10 in their national ranking of top law schools in 2009. Faculty who teach in the fields of health law and legal writing ranked the Hall Center for Law and Health as 10th and the legal writing program (Legal Analysis Research and Communication or LARC) as 8th. Also, our school was ranked as 7th in the Top 10 of public law schools offering a part-time program.

**Hall Center for Law and Health**, as part of its work on Health Reform, collaborated with the Center for Health Policy to release an Issue Brief entitled *Public Health Programs' Key to Healthy Population, Lower Healthcare Costs*. Indiana ranks 34th in the nation in Public Health Indicators and 50th in per capita Public Health expenditures.

### **Program on International Human Rights Law**

J.D. and LL.M. students gave an oral intervention and a one-hour private briefing to the UN Human Rights Committee about women's rights violations and women's political marginalization occurring in Chad. The students presented their key findings and recommendations, contained in a 40-page shadow report, "Chad's Breach of the International Covenant on Civil and Political Rights: Failure to Protect the Rights of Women and Girls," to the Committee's Chad Task Force during spring break in New York City. The students' report included two affidavits with one made by a rights violations victim. The students belonging to the law school's International Human Rights Law Society also discussed their factual findings and recommendations stated in their report to the Committee. The briefing was held at the Office of the High Commissioner for Human Rights.

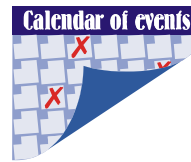

## WANT TO START PRACTICING BEFORE YOU LEAVE LAW SCHOOL?

Enroll in one of our in-house clinics and represent clients with the guidance of one of the law school's faculty

### **Civil Practice Clinic**, (3 or 4 credits, Pass/Fail)

Students advise and represent clients in general civil matters. These matters include family law, property, administrative law, and a number of other miscellaneous civil matters. Students are certified to practice under the Rules for Admission to the Bar.

### **Criminal Defense Clinic**, (3 or 4 credits, Pass/Fail)

Students represent persons charged with Class D felonies. Students are certified to practice under faculty supervision pursuant to Rules for Admission to the Bar.

### **Disability Clinic**, (2 credits, Pass/Fail)

Students interview, counsel, and provide administrative representation to persons with physical or mental disabilities. Legal problems include initial disability determinations for Supplemental Security Income, continuation of disability benefits, and other matters related to benefits from the Social Security Administration.

### **Wrongful Conviction Clinic**, (2-3 credits, Pass/Fail)

Students represent indigent clients seeking relief from wrongful convictions in state post-conviction and/or federal habeas corpus proceedings. State cases are accepted in cooperation with the Office of the State Public Defender. Students consider federal and state post-conviction remedies and the relevant issues, including eyewitness identifications, false confessions, informants, government misconduct, junk science, and DNA testing.

### **Immigration Clinic**, (2 or 3 credits, Pass/Fail)

Students represent both detained and non-detained clients in immigration matters before federal administrative agencies under supervision of professor/counsel. Typical cases involve claims of asylum, family-based immigration petitions (including domestic violence) and crime victim visas.

### **Appellate Clinic**, (2 credits, Pass/Fail)

Students represent indigent clients in civil or criminal appeals. Students are responsible for all aspects of representation, including client communication, drafting motions and briefs to the Indiana Court of Appeals, presenting oral argument and litigating a petition to transfer to the Indiana Supreme Court.

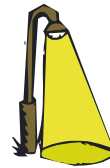
## Spring Semester Course:

## Faculty, Staff & Students in the Spotlight!

**Prof. Cynthia Baker**, Director of the Program on Law & State Government, has been appointed by *Governor Mitch Daniels* to the Indiana Commission of Higher Education. Congratulations!

**Matt Banker**, Assistant Dean of Student Affairs, was elected by SBA elections to receive the White Cane Award for Best Administrator. The award was presented at this year's Barristers' Ball, which was held during the spring '09 semester.

**Prof. Karen Bravo** was invited to present a poster of her research entitled "Follow the Money? Does the International Fight Against Money Laundering Provide a Model for International Anti-Human Trafficking Efforts?" at the 103rd American Society of International Law (ASIL) Annual Meeting, held in Washington, D.C. March 25-28.

**Prof. Dan Cole** was invited to become a member of the Board of Advisors of the Institute for Policy Integrity at New York University Law School. He was invited based on his past written articles and book chapters on issues relating to the theory, method, and practice of cost-benefit analysis (or regulatory impact analysis) in the federal government. The Institute for Policy Integrity is a non-partisan think tank and advocacy organization for the use of properly conducted cost-benefit analysis to promote socially beneficial regulation. The institute advocates for regulatory programs using cost-benefit analysis, and advocates for reforms in cost-economically justified regulations. The board of advisors is made up of academics and leaders in government, business, and in the advocacy community.

**Prof. Eric Dannenmaier** was cited by the Phillippines Supreme Court Chief Justice in a dispute over the release of negotiating documents from a trade agreement. The Court denied a petition to release the records but its Chief Justice dissented, citing nine separate times at length from Professor Dannenmaier's 2004 article "Trade, Democracy, and the FTAA: Public Access to the Process of Constructing a Free Trade Area of the Americas," (1066 Fordham Int'l Law J. 1078) in support of his position that the document should have been released. **Dean Gary Roberts, Jim Nehf**, Associate Dean for Graduate Studies, and **Claire Grove**, Assistant Dean for Graduate Studies, traveled to Seoul, Korea, to attend an IU International Alumni Event June 5-7. From Seoul, they flew to Beijing, P.R. China to visit the law school's partners at Renmin University, which hosts the Chinese Law Summer Program for IU School of Law-Indianapolis. In addition, Dean Roberts coordinated with graduates in Beijing to organize an alumni reception and dinner during the visit. Before returning to the U.S., the deans visited Nanning, P.R. China, where Dean Roberts and Dean Nehf gave presentations to the Guangxi Bar Association.

**Prof. George Edwards** was chosen as a recipient of IUPUI's Prestigious External Award Recognition (PEAR). IUPUI Chancellor Charles Bantz presented Professor Edwards with the PEAR award at the Chancellor's Academic Honors Convocation on April 17, 2009. The award was in honor of Professor Edwards receiving the National Bar Association's (NBA's) Ronald Harmon Brown Award of International Distinction in August, 2008. (This award was established in memory of the first African American to become the United States Secretary of Commerce, Ronald Harmon Brown, 1941-1996.) **Professor Edwards** participated in an international conference in Taipei, Taiwan, July 23-24. The conference was sponsored by the Asian Centre for World Trade Organization (WTO) and International Health Law and Policy. The WTO Centre is part of New Taiwan University, the premier university in Taiwan. At the Taipei conference, Professor Edwards delivered a paper entitled "Human Rights and International Trade: From the 17th Century Trans-Atlantic Slave Trade to Hurricane Katrina, the World Trade Organization (WTO), Human Trafficking and the Right to Health." **Prof. Frank Emmert** gave a lecture entitled "Reflections on How To and How Not To Establish Antitrust Oversight in Emerging Markets and Transitional Economies" at the Spring Antitrust Meeting of the American Bar Association (ABA) in Washington D.C. on March 27th.

**Prof. John Hill's** book *The Political Centrist* (2009 Vanderbilt University Press) will be released in November 2009. In his book, Professor Hill examines the decline of "liberal"

and "conservative" ideology and the growth of a "centrist" approach to contentious contemporary political and social issues such as abortion, affirmative action, the death penalty, gay marriage, illegal immigration, judicial activism, and other key issues.

**Prof. Eleanor Kinney** testified on July 27th before the House Energy and Commerce Committee's field hearing in New Albany, IN, as an expert on insurance and health law. She was asked to talk about the situation in Indiana regarding health insurance, and experiences of Hoosiers with rescission of private health insurance contracts and post claims underwriting. (This allows insurers to do their underwriting and decision-making about whether an insurance policy is valid after it has sold the individual.) Professor Kinney also discussed the provisions in HR 3600, 111th Cong., to limit the practices of rescission and post claims underwriting.

**Prof. Andy Klein** was voted by SBA elections to receive the Black Cane Award for Best Overall Professor. The award was presented to Professor Klein at this year's Barristers' Ball, which was held during the spring '09 semester.

**Prof. David Orentlicher** discussed health care reform in the May 6th issue of the *Journal of the American Medical Association*, and described components of a reform package that are necessary to achieve universal coverage. He also spoke in Flint, Michigan in March at a conference entitled "The Face of Our Future. Stem Cell Research: It's Political Ramifications, Ethics and Risks, Alternative Options & More." The event was part of the Ballenger Eminent Persons Lecture Series at the Foundation for Mott Community College. His presentation was entitled "Stem Cells: Ethical Considerations."

**Prof. Antony Page** taught and lectured at two Chinese law schools in May and June as a resident professor for the Chinese Law Summer Program. The Program is held in Beijing at the Renmin University of Law, which recently announced it was ranked 1st among China's law schools. He also delivered lectures to faculty and Ph.D. students in law at the China University of Political Science and Law.

**Prof. Michael Pitts** was voted by SBA elections to receive the Red Cane Award for Best new professor of 3 years or less. This award was presented to Professor Pitts at this year's Barristers' Ball, which was held during the spring '09 semester. Congratulations!

**Prof. Florence Roisman** spoke at a conference entitled "Human Rights and State Law: New Strategies for Economic Justice Advocacy," which was sponsored by the Human Rights Institute at Columbia Law School. On April 17 in New York City, Professor Roisman's panel, entitled "Why Human Rights?," explored reasons why social justice lawyers should consider using human rights standards to advocate for economic human rights in state law. Panelists addressed the relevance of human rights standards in interpreting

state constitutional provisions and statutes in developing state common law. They also addressed the relationship between international and foreign law and state/municipal law, and ways in which lawyers can incorporate human rights standards into their legal analysis by drawing on international and foreign law for interpretive purposes. Professor Roisman is the author of the article, "Using International and Foreign Human Rights Law in Public Interest Advocacy," 18 *Indiana International and Comparative Law Review* 1, (2008).

**Mark Shope**, 1L, co-presented with *Professor George Edwards*, "American Legal Education: What International Students Want To Know About Studying Law In The United States." The presentation was held at the offices of US Department of State affiliate, the American International Education Foundation (AIEF), Taipei, Taiwan, in July.

**Matt Trick**, 3L, gave a power point presentation to a group of Ghanaian law students at the US Embassy in Accra, Ghana, during his visit in July. Matt was in Ghana as an IU-Indianapolis Law intern for the Program in International Human Rights Law.

**Prof. Tom Wilson** taught and lectured at two Chinese law schools in May and June as a resident professor, along with Professor Page, for the Chinese law Summer Program. Professor Wilson is Co-Director for the summer program, which began in 1987. While in Beijing, he also lectured to faculty and Ph.D. students in law at the China University of Political Science and Law.

**FIRE:** Alarms will sound and evacuation is mandatory. Use closest stairway for exits. **DO NOT USE ELEVATORS.** Once outside, move to a safe place, if possible, to the parking lot west of the law school. Remain outside until the "all clear" is given.

**TORNADO WATCH:** The "campus siren" will sound - evacuation is NOT required.

**TORNADO WARNING:** Three blasts of an air horn in the Atrium will indicate **evacuation is necessary.** Evacuate **immediately** to the parking garage and use only the NW and SOUTH stairwells which have direct garage access. Remain in garage until an "all clear" is given.

(Note: Procedures are posted in all classrooms.)



## IUPUI Shuttle Service

The IUPUI shuttle system operates all year, Monday through Friday, except during university recognized holidays. There are 3 shuttle routes: Campus, Off-Campus, and HITS Express. 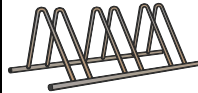

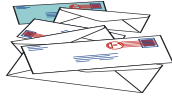
